

EXCELL DANCE CONTRACT

Standard monthly tuition* is **\$60.00 for sixty minute classes and \$90.00 for ninety minute classes, and is** due by the 5th of each month. Fall Registration fees are \$35.00 per student and \$55.00 per family. Registration Fees are collected annually and are due upon registering for the year. Note: Fees are paid ONE time per year and are non-refundable. Summer Session class pricings vary and a registration fee is included in the price. Tuition for Summer Sessions is due upon registration and before class attendance will be permitted.

ANY DROPPED CLASS REQUIRES PRIOR WRITTEN NOTICE. Payment in full on all outstanding balances is required on the date of withdrawal from the class. Without full payment of this balance, your dancer will still be considered as an attending student, and regular monthly tuition will be charged to you. In addition, late fees may be applied to outstanding balances each month they are overdue.

Tuition received after the 15th of the month will incur a \$10 late fee for the month, and each following month it remains overdue.

Any account more than 90 days past due will be turned over to a collection agency. There will be a \$25.00 service fee on all returned checks.

Please do not leave payment with the front desk at the WARF.

Monthly tuition remains the same regardless of breaks, holidays, length of the month, snow days, or student illness (unless in exceptional circumstances). Refer to our website, www.excelldancers.com, for complete holiday schedules.

Make up classes may be held for cancellations due to inclement weather.

There are NO REFUNDS on registration, tuition, or recital and costume fees.

Students (excluding Creative Movement Level 1) will perform in an annual recital. Due to recent increase in enrollment, all classes will perform ONE recital number, regardless of whether they are in a "combined discipline" class. A small recital fee may be charged to cover recital costs. Students are responsible to pay for their own costumes, which the company will order. All accounts must be paid in full by the first week of May in order for students to receive costumes and/or participate in Spring Recital. Costumes are yours to keep.

Inclement Weather Policy: Excell Dance LLC will follow Fauquier County School's inclement weather policy. A change in this schedule will be under the director's discretion. There is no guarantee of make up classes for cancellations due to inclement weather.

Students are expected to attend the full term for which they register. By signing this document you are agreeing to pay the monthly tuition for the full season you register for. A fee may be charged for early cancellation.

Drop off and Pick up: Please walk your children into the dance studio to check in with the instructor. Please do not drop off children in the parking area. Please also enter the studio to pick up your children. Please drop off and pick up your children in a timely manner.

Excell Dance Company will charge customers for the instructors' time if students are picked up late.

Observation: Occasionally, at the teacher's discretion, observation days may be held in the studio. Please respect the instructors and students by not distracting them during class. We ask that all parents keep the windows and doorways clear to avoid crowding the halls and distracting the students.

Students must provide and bring their ballet/tap/jazz shoes and all supplies in a labeled tote bag. Please label all belongings with name.

Attire for all classes includes: Leotard and tights/ leggings/ stretch pants/ dance skirts. Please get any style or color guidelines from individual instructors. Students are expected to wear hair pulled away from their face as not to impair vision while dancing.

Excell Dance LLC and staff members hold the right to dismiss any student(s) due to inappropriate or disruptive behavior. Upon dismissal from class(es) a parent will be contacted and expected to pick up student immediately.
